The investment choice ended with “(Dis)” in its name (the “Investment Choice (Cash Distribution)”) linked to the share class of the corresponding underlying fund which aims to distribute cash dividend on a regular basis. Investment Choice (Cash Distribution) are made available to Legend and Legend 2. If you choose to invest in the Investment Choice(s) (Cash Distribution), you will receive cash dividend if CTF Life receives such dividend from the underlying fund(s) of the Investment Choice(s) (Cash Distribution). Investment Choices

The investment choices are offered by CTF Life under the Scheme. The investment choices are respectively linked to underlying funds. CTF Life will be investing the premium received from you into the underlying funds corresponding to the investment choices selected by you for CTF Life’s asset liability management.

Dividends of Underlying Funds

Dividends may be (1) reinvested and allocated to your policy as additional notional units of the relevant investment choice equal to the amount of dividend distributed, or (2) distributed to the owners in cash if the Investment Choice (Cash Distribution) is selected.

If a dividend is declared for the underlying fund of an investment choice other than Investment Choice (Cash Distribution) while the policy is still in force, CTF Life will reinvest the dividend amount in the form of additional notional units into the investment choice. We will allocate such notional unit(s) within 12 business days upon the receipt of such dividend from the underlying fund by CTF Life. However, this allocation may be delayed due to any exceptional circumstances which is beyond the control of CTF Life as set out in the section of Exceptional Circumstances of the Investment Guide. If reinvestment is not feasible in the case of policy surrender, termination, switching-out, or other circumstances, we will pay the dividend to the owner by cheque or other means which will not affect your entitlement to the payment of dividend payout. The dividend amount reinvested will form part of the account value and may be subject to applicable fees and charges. For dividends declared in respect of the underlying fund of an Investment Choice (Cash Distribution), please refer to the section of Distribution Policy of Investment Choice (Cash Distribution).

Distribution Policy of Investment Choice (Cash Distribution)

Cash dividend

When an underlying fund of an Investment Choice (Cash Distribution) declares dividend on a date, we will record the number of notional units of the Investment Choice (Cash Distribution) the owner is entitled to in the policy on that date. This date is referred to as the record date (“Record Date”). Such Record Date shall be the same day as the day that the dividend is declared by the underlying fund corresponding to the Investment Choice (Cash Distribution).

The dividend amount (rounded to the nearest two decimal places) to be distributed for each Investment Choice (Cash Distribution) in a policy is determined as follows:

The dividend amount per notional unit of the Investment Choice (Cash Distribution) will be in the exact dividend amount per unit in the currency declared by the underlying fund of the Investment Choice (Cash Distribution). Any remaining balance of the dividend after rounding will be borne or absorbed by CTF Life.

Entitlement to cash dividend

The owners holding notional units of the Investment Choice (Cash Distribution) on the Record Date are entitled to receive cash dividend given the dividend declared and becomes payable by the corresponding underlying fund and the policy is still in force on the Record Date. For the avoidance of doubt, any (1) cancellation of your policy during the cooling-off period, (2) termination of your policy or (3) cancellation of the relevant notional units of the Investment Choice (Cash Distribution) as a result of switching or partial withdrawal, subsequent to the Record Date, will not affect the entitlement to the cash dividend and the amount of cash dividend previously paid to you (if any) will not be clawed back from your policy.

Frequency of distribution

The frequency of distribution of an Investment Choice (Cash Distribution) will be the same as the frequency of distribution of its underlying fund. Cash dividend of an Investment Choice (Cash Distribution) will be distributed to you after payment of dividend from its underlying fund is received by CTF Life.

Payment of cash dividend

Early redemption charge does not apply to the cash dividend distributed from the Investment Choice(s) (Cash Distribution). If you hold notional units of an Investment Choice (Cash Distribution) on the Record Date and dividend is declared by its underlying fund, we will normally pay you the cash dividend you are entitled to within 12 business days upon receipt of the cash dividend from the underlying fund of the Investment Choice (Cash Distribution) by CTF Life. CTF Life may extend the payment period due to any exceptional circumstance which is beyond CTF Life’s control, and payment will be carried out as soon as practicable after cessation of such event. No interest on the cash dividend will be paid to the owners by CTF Life in respect of the period between the Record Date and the date of payment.

Payment of cash dividend will be made in Hong Kong Dollars by autopay or other payment methods offered by CTF Life at the time of payment. For Legend 2, you may also elect to receive the dividends in the policy currency by filling a written request in our prescribed form subject to our approval. We will convert the cash dividend denominated in the currency of the Investment Choice(s) (Cash Distribution) into Hong Kong Dollars or US Dollars upon request and agreed by us for US Dollars policy at the prevailing exchange rate as determined by CTF Life from time to time in good faith and a commercially reasonable manner and it may be subject to foreign exchange risks in the process of currency conversion. There is no handling fee and charge imposed by CTF Life in respect of the dividend payment method or currency conversion. Any charges incurred in connection with currency conversion or payment of cash dividends by autopay or any payment method shall be borne by you and will be deducted from the proceeds of dividends.

CTF Life reserves the right to amend the distribution policy and the related administration arrangement of Investment Choice (Cash Distribution) subject to the prior regulatory approval and by giving not less than one month's prior written notice (or such shorter notice period in accordance with the relevant regulatory requirements) to the owners.

The amount of dividend paid by the Investment Choice (Cash Distribution) and the dividend composition information of the underlying fund for the last 12 months and will be made available upon request and on our website. Please refer to www.ctflife.com.hk/cash-dividend-fund/en/ for further information.

Valuation of Investment Choices

We will calculate all the allocation (e.g. the allocation of premium) and cancellation of notional units (e.g. surrender) to / from the investment choice(s) at unit price.

All of the investment choices have no bid-offer spread. As there is no bid-offer spread, both the bid price and the offer price of an investment choice is equal to the unit price of the same investment choice.

The unit price of a unit of each investment choice on a valuation date will be the same as the offer price of the unit or share of that underlying fund on that valuation date and in the currency of that underlying fund.

A valuation date of an investment choice is equal to every working day. In the event of the occurrence of any exceptional circumstances, beyond CTF Life's reasonable control which renders it impracticable to carry out a transaction on a particular valuation date, we shall have the discretion to decide another applicable valuation date to determine unit price and / or the net asset value of an investment choice.

Underlying fund units are currently bought and sold on every working day subject to valuation policy of the underlying fund, and on a forward-pricing basis. CTF Life reserves the right to delay carrying out the valuation and the processing of requests to allocate, cancel or switch notional units of investment choice(s) for switching request or payment of surrender value, partial withdrawal amount, death proceeds (including suicide proceeds), maturity benefit or cash dividend distributed from the Investment Choice(s) (Cash Distribution) caused by exceptional circumstances beyond CTF Life's control. The exceptional circumstances include, without limitation, the closure of or suspension of dealings on a major stock exchange, unexpected government intervention in foreign exchange, and suspension of valuation of, or dealing in any underlying investments of an investment choice. No interest shall be paid by CTF Life in respect of any delays in payments due to such exceptional circumstances.
